7.1 Financial Statement ending October 31, 2024

The Registrar introduced this topic. Council reviewed the Variance Report, Balance Sheet, and Revenue and Expenses Statement ending October 31, 2024.

7.2 Minimum Balance for Reserve Funds

Ms. Shilo Tooze, Deputy Registrar and Ms. Lesley Rankin, Director, People and Resources joined the table. Ms. Tooze noted that each year with the College's budget, Council reviews proposed spending, including special projects funded from the College's reserves. Ms. Tooze outlined the proposed unrestricted reserve targets for 2024/2025. Council, at budget time will be asked to confirm the level of unrestricted reserves that are needed for the upcoming year and determine if the College's revenue is sufficient to meet the needs in the future or if fee amounts need to be reviewed.



A discussion ensued and Ms. Tooze answered questions posed by Council.

9.1 After-Hours Veterinary Care

Dr. Claire Beauchamp, Chair of the After-Hours Care Task Force, introduced this agenda item and Ms. Sarah Kirby, Director, Policy and Ms. Kali Pieters, Policy & Projects Coordinator joined the table to answer any questions.

Dr. Beauchamp provided an update on the progress of the After-Hours Care Task Force. A fulsome discussion ensued, and Dr. Beauchamp and the Registrar answered questions posed by Council.

Council directed that the Taskforce recommendations be approved as presented.

Council directed that the Taskforce recommendations be forwarded to Transition Council for its use in regulation development.

Council thanked the Task Force, Dr. Beauchamp and Ms. Pieters for their work on this project.



9.2 Guideline – Use of Medical Devices Enabled by Artificial Intelligence

Ms. Shilo Tooze, Deputy Registrar joined the table. Dr. Jessica Retterath introduced the topic. She noted that the Legacy Council adopted the Position Statement, "Embracing Innovation and the Digital Age in Veterinary Medicine," in March 2024. After the approval of the Position Statement, the College's Ontario Veterinary Regulatory Innovation Panel (OVRIP) has been providing advice to assist in formulating a guidance document to support the use of tools enabled by artificial intelligence by veterinarians.

Dr. Retterath noted that Legacy Council is not generally involved in the approval of guidance documents, however, College staff wanted to ensure that the Legacy Council was aware of the information provided to veterinarians in this risk area.

A fulsome discussion ensued with Councillors providing positive feedback. The document will be published and posted to the College's website.

Organization Policy

10.1 By-Law Proposed Amendment – Non Councillor Committee Member Terms and Sunsetting the Governance, Audit and Risk Committee

Ms. Shilo Tooze, Deputy registrar joined the table. She noted that at its last meeting in September 2024 Council discussed its need to maintain stability and focus on member related matters during the transition period as the College moves toward implementation of the new Veterinary Professionals Act. Two By-law changes were approved for consultation, including non-council committee member terms and sunsetting the Governance, Audit and Risk (GAR) Committee. These proposed By-law changes were circulated for 60 days and feedback was provided to inform Legacy Council in its decision making.

A discussion ensued and the Registrar answered questions posed by Council.

The Competition Bureau is showing interest in prescription medicine in veterinary medicine. CBC Marketplace is also showing interest on this topic. The Registrar noted that the CVMA will be key contributors to the Marketplace segment. She reminded Council that should they be contacted by media to refer them to Ms. Kim Huson, Director, Communications.
