### **<u>TOPIC:</u>** Proposed Regulatory Exemption for Farriers and Hoof Trimmers

### **History of Topic**

Through conversations with both veterinary and agricultural communities, the College became aware of the need to consider the ability for certain non-animal veterinary care providers to perform farriery and/or hoof trimming services for animals.

Given this, a regulatory concept related to a regulatory exemption for farriers and hoof trimmers was developed.

#### Legislative Framework

Section 9 of the *Veterinary Professionals Act, 2024 (VPA)* establishes the legislative authority for the development of an authorized activity model for the practice of veterinary medicine in Ontario.

Section 9 (5) of the *VPA* permits persons (who are not members) to perform certain authorized activities subject to any prescribed guidelines, processes, terms, conditions, limitations, or prohibitions outlined in Regulation.

This ability is further confirmed in Section 93 (1) 7 of the *VPA* which allows for the development of regulation language permitting persons who are not members to carry out specified authorized activities and limiting and governing the carrying out of such activities.

# **Development of Regulatory Concept by Transition Council**

Transition Council reviewed and forwarded for public consultation a regulatory concept related to a regulatory exemption for farriers and hoof trimmers in November 2024. This concept included:

1. Regulatory Exemption for Farriers and Hoof Trimmers

Transition Council proposed the development of regulation language to permit the performance of the following authorized activity by a person engaging in farriery or hoof trimming services:



- Performing a procedure below the dermis if it remains within or below the coronary band and within the structures of the hoof.
- 2. Additional Recommendations for Qualification under the Regulatory Exemption

Transition Council proposed that the development of regulation language related to farriers and hoof trimmers be further restricted to also require a person to adhere with the following guidelines, processes, terms, conditions, limitations, and/or prohibitions:

A person would not be required to provide proof of their eligibility related to these qualifications to the College of Veterinary Professionals of Ontario (CVPO). Instead, a person would be expected to review the regulatory exemption and determine whether they meet the requirements.

Should the CVPO become aware of a person who is providing farriery or hoof trimming services to the public who may not meet these requirements, the CVPO could investigate these concerns including requesting proof of eligibility and adherence, and pursue further action including the ability to investigate under either unauthorized practice and/or the risk of harm clause if warranted.

# **General Consultation Feedback**


The regulatory exemption for farriers and hoof trimmers was included in the list of regulatory concepts that were circulated for public consultation from February 11 to April 16, 2025.

The following quantitative responses were received related to the proposed regulatory exemption:



Transition Council

Survey respondents were asked to indicate their agreement with a statement about Farriers and Hoof Trimmers on a Likert scale of responses from "Strongly disagree" to "Strongly agree". The figure below presents the results of 412 responses to the statement "*The proposed conditions and permitted authorized activities for farriers and hoof trimmers are appropriate to protect the public.*".



In addition to the quantitative data, the following qualitative trends were noted:

- Suggestions to include a requirement for proof of eligibility;
- Suggestions to include a requirement for interprofessional collaboration; and
- Requests for clarity around the term "below the dermis".

# **Consultation Feedback from Key Partners**

#### Ontario Veterinary Medical Association (OVMA)

In its April 15, 2025, submission the OVMA shared:

- Suggestion to include a requirement for interprofessional collaboration between farriers /hoof trimmers and veterinarians; and
- Suggestion to require veterinarian involvement when farrier and hoof trimmer services extend below the dermis or require drawing blood.

#### Ontario Association of Veterinary Technicians (OAVT)

In its April 16, 2025, submission the OAVT shared:

- Suggestion that the regulatory concept be revised to specify that performing a procedure below the dermis if it remains within or below the coronary band and within the structure of the hoof only be done by a farrier or hoof trimmer with veterinarian oversight; and



 Question of whether this exemption grants greater autonomy for unlicensed individuals to perform authorized activities than veterinary technician members given veterinary technician members would not be permitted to perform the procedures if they verge on major surgery.

- Suggestion that the regulatory concept include a requirement for collaboration or consultation with a veterinarian

### **Further Information Gathered Based on Consultation Feedback**

1. Maintenance vs. Therapeutic Procedures

Comments related to the differences between maintenance vs. therapeutic procedures done on the hoof of an animal raised the opportunity for additional research and consideration of whether further distinction between these two types of services was required. In reviewing the submissions provided, as well as in further conversation with a trusted veterinarian working in this area of practice, it was determined that there was a defensible and evidentially sound desire to create a clearer divide between maintenance versus therapeutic farriery and/or hoof trimming to ensure that the performance of higher risk activities (i.e., therapeutic) remained directly connected to the veterinary profession.

# Additional Context to Assist with Decision-Making

Based on this work, Transition Council is asked to consider the following amendment to the regulatory concept on a regulation exemption for farriers and hoof trimmers:

- That persons who meet the qualifications outlined above be permitted to perform a maintenance procedure below the dermis if it remains below the coronary band and within the structures of the hoof; and



- That persons who meet the qualifications outlined above be permitted to perform a therapeutic procedure below the dermis if it remains within or below the coronary band and within the structures of the hoof only if they do so in cooperation and collaboration with a veterinarian member.
